Literacy Kansas City certifies volunteers as tutors and matches them with adult learners from across the Kansas City metropolitan area who want to improve their literacy skills. Free One-to-one training uses a phonics based, one-to-one teaching approach that helps students learn to "sound out" words. Both students and tutors are asked to make a one-year commitment to the program upon joining. The GEARS program is designed for the remedial reader. Along with class meetings, students are placed with a tutor and meet with them twice per week as part of the one-to-one tutoring program. Literacy Kansas City offers the Open Doors program which is an expansion of the existing adult literacy program and targets state offenders supervised by Probation and Parole officers in Jackson County, Missouri and uses the proven reading instruction program to develop ex-offenders reading skills, enabling them to attain the additional education or training necessary to be a productive, law-abiding citizen. Literacy Kansas City also offers a computer lab with reference software, typing tutorials, high-speed internet and e-mail access to assist students with technology. The organization garnered auction items valued at over \$40,000 for their Spelling Bee held in April 2013.

The Organization recognizes the financial statement benefit of a tax position only after determining that the relevant tax authority would more likely than not sustain the position following an audit. For tax positions meeting the more-likely-than-not threshold, the amount recognized in the financial statements is the largest benefit that has a greater than 50% likelihood of being realized upon ultimate settlement with the relevant tax authority. The Organization is subject to income tax regulations in the U.S. federal jurisdiction and certain state jurisdictions. Tax regulations within each jurisdiction are subject to the interpretation of the related tax laws and regulations and require significant judgement to apply. With few exceptions, the Organization is no longer subject to income tax examinations by the applicable tax authorities for the years before 2010. If any were to be incurred, the Organization's policy is to record penalties and interest assessed by income tax authorities as operating expenses.

Schedule D, Part XI, Line 2d - Direct fundraising costs of \$34,338 were netted against income. Audit included 13 months from June 2012 thru June 2013, so \$34,591 June 2013 net income was removed from 990 revenue.
