

Literacy Kansas City certifies volunteers as tutors and matches them with adult learners from across the Kansas City metropolitan area who want to improve their literacy skills. Free one-to-one training uses a phonics based, one-to-one teaching approach that helps students learn to "sound out" words. Both students and tutors are asked to make a one-year commitment to the program upon joining. The GEARS program is designed for the remedial reader. Along with class meetings, students are placed with a tutor and meet with them twice per week as part of the one-to-one tutoring program. Literacy Kansas City offers the Open Doors program which is an expansion of the existing adult literacy program and targets state offenders supervised by Probation and Parole officers in Jackson County, Missouri and uses the proven reading instruction program to develop ex-offenders reading skills, enabling them to attain the additional education or training necessary to be a productive, law-abiding citizen. Literacy Kansas City launched the Family Reading Program in June 2014. The Family Reading Program, in partnership with the Kansas City Public Schools and the library systems in Kansas City, is focused on teaching the parent in order to reach the child. The program uses an innovative, multi-generational approach to teaching literacy in order to combat intergenerational illiteracy. Adult students attend
